- 5. **DRILL:** Scientology Drug Rundown procedure on a doll. Coach answers for the doll and holds the cans, squeezing the cans to simulate reads. The coach prepares a list of drugs using fruit instead of actual drugs. The student drills the steps of the rundown beginning with:
 - A. Preliminary Steps. Student does all actions involved in the Preliminary Steps. On any flunk, the coach shows the student the exact LRH reference violated. The drill is passed when the student has demonstrated he can standardly do the preliminary steps of the rundown. _____
 - [Note: If the student has not been trained to Fly ruds, this step is skipped. These procedures are not taught as part of this co-audit course. Unless the student has been trained on flying rudiments earlier, the Supervisor will arrange for another to fly ruds if they are needed in your co-audit sessions.]
 - B. Drug Rehabs. Sudent does all actions involved in the drug rehabs. On any flunk, the coach shows the student the exact LRH reference violated. The drill is passed when the student has demonstrated he can standardly do the rehab steps of the rundown. _____
 - C. Recalls on Drugs. Student does all actions involved in the Recalls on Drugs. On any flunk, the coach shows the student the exact LRH reference violated. The drill is passed when the student has demonstrated he can standardly do the recall steps of the rundown. _____
 - D. Objective Process. Student does all actions involved in the Objective Process. On any flunk, the coach shows the student the exact LRH reference violated. The drill is passed when the student has demonstrated he can standardly do the Objective Process on the rundown. _____
